



The Honourable A. Anne McLellan, P.C., O.C. joined Bennett Jones LLP in its Edmonton office July 4, 2006. Ms. McLellan provides strategic advice to the firm and its clients.

On May 12, 2006 she was appointed Distinguished Scholar in Residence at the University of Alberta in the Alberta Institute for American Studies. In 2007 the University of Alberta awarded Ms. McLellan

an honorary doctorate of laws degree and in July 2009 Ms. McLellan was appointed an Officer of the Order of Canada.

Ms. McLellan serves on the Board of Directors of Nexen, Agrium, Cameco and the Edmonton Regional Airport Authority. Among her many community commitments she Chairs the Board of the Royal Alexandra Hospital Charitable Foundation and sits on the Boards of Habitat for Humanity Edmonton Society, TELUS Edmonton Community Board and the Edmonton Community Foundation Board. She also served as a member of the Premier's Council for Economic Strategy where she provided "guidance on actions the Alberta government can take to best position the province for the future."

Ms. McLellan served four terms as the Liberal Member of Parliament for Edmonton Centre from October 25, 1993 – January 23, 2006. She served as Deputy Prime Minister of Canada and the first Minister of Public Safety and Emergency Preparedness (December 2003 – January 2006), Minister of Health (January 2002 – December 2003), Minister of Justice and Attorney General of Canada (June 1997 – January 2002) and Minister of Natural Resources and Federal Interlocutor for Métis and Non-Status Indians (November 1993 – June 1997).

She holds a Bachelor of Arts and a Law degree from Dalhousie University and a Master of Laws degree from King's College, University of London. Ms. McLellan was admitted to the Bar of Nova Scotia in 1976.

Dr. Shrivastava received his Ph. D. from the University of Pittsburgh. He was tenured Associate Professor of Management at the Stern School of Business, NYU, and held the Howard I. Scott Chair in Management at Bucknell University. He has published 17 books and over 100 articles in scholarly and professional journals. He has served on the editorial boards of numerous leading management education journals including the Academy of Management Review, the Strategic Management Journal, Organization, Organization and Environment, and Business Strategy and the Environment. He won a Fulbright Senior Scholar Award to study Japanese corporate environmental management at Kyoto University. His work has been featured in the Los Angeles Times, the Philadelphia Inquirer, the Christian Science Monitor, and on the McNeil-Lehrer News Hour.


